

I have attached the components and quantities required by the USDA for healthy eating. Underfeeding and overfeeding children are both harmful (see the attached article on childhood obesity).

Please use the attached guidelines when spooning out quantities to your children.

Also practice encouraging children to eat all components. Tell them they can have a 2nd donut when they finished their ½ to ½ cup of fruit. Note that 2-year-olds should only be served ¼ cup of cereal and ¼ cup of fruit for breakfast, and 3-5 year-olds should be served ½ cup of fruit and 1/3 cup of cereal.

Childhood Obesity: The Reality Check

hildhood obesity is headline news. The number of overweight children has risen dramatically over the past two decades, and doctors and scientists are very concerned.

Ten years ago, type 2 diabetes, gallstones, and liver failure were diseases doctors found in middle-aged adults. Now the patients are children, aging before their time, showing symptoms of hypertension, breathing disorders, sleep problems, and bone-and-joint complications. It will take all of us together—parents, doctors, caregivers, schools, and insurance companies—to stop this heartbreaking trend.

According to the National Center for Health Statistics, about 34 percent of U.S. children ages 6 to 19 are overweight. They are at greater risk of developing heart disease and some forms of cancer. Research shows that if overweight problems begin before 8 years of age, obesity in adulthood is likely to be more severe. Type 2 diabetes, formerly referred to as adult-onset diabetes, now represents up to 45 percent of new diagnoses of diabetes in children and adolescents. Unlike juvenile diabetes, or type 1, it is linked to weight.

The Facts:

• Seventeen percent of American children are obese.

- Only 8 percent of elementary schools have physical education classes.
- Twenty percent of children consume more than four sodas a day.

In light of these facts, parents realize that they have the responsibility and power to instill healthy eating habits in their children. Your family probably enjoys certain foods such as macaroni and cheese or pizza. With just a few changes, these and many other favorites can be made healthier and just as satisfying. The recipe database at wwwfruitsandveggiesmatter.gov offers a hearty Pasta Primavera as an alternative to mac and cheese, and veggiepacked Tortilla pizzas in place of traditional high-fat pizzas. The Web site also offers new ideas about how to add more tempting fruits and vegetables to your daily diet. Parents must also be diligent about portion sizes—they've been creeping up over the past several years. If a box of cereal says a serving is 1 cup, then that's what is





- 1. "When I first came my toddler got a report of what happened each day... but after the first month it stopped! I like knowing when he ate or when he was outside or if he napped well."
- "My four-year old is always dirty when I pick him up sometimes loses his shoes, belt or sweater and whoever is there in the afternoon always says she can't find anything."
- "When I come in the morning it's a mad house. There are enough staff but they don't split the kids up enough."
- 4. "I never know where to leave my child. If I arrive before 8 a.m. there is no one in his room and no one is willing to take him."
- 5. "I never knew when field trips were planned, or when they were cancelled."
- 6. "Lately, my daughter hasn't been involved in a great deal of activities like painting and crafts."
- 7. "My four-year old doesn't seem to do school preparation activities such as reading (or being read to) or practicing printing."
- 8. "It seems as if most of my son's computer experience involves the Nintendo."
- 9. "It seems as if when I come and pick up my school-age daughter, they are all sitting down at tables with the heads down."
- 10. "If the children are outside when I arrive, there is usually no one there who can tell me where the children are right away."

Starling is a No Bully Zone

Dear Parents and School Age Children,

I am writing to explain that I have a policy for our school age children. Although bullying is not a major problem at Starling, I want to "build a culture of awareness" about the issue.

There is no serious physical bullying at Starling, but words sometimes hurt even more! Bullies act out because they don't feel good about themselves. At Starling we start early getting kids to feel good about themselves. Therefore, we have zero tolerance for kids hurting or "tearing down" other children through unkind words.

A message to all children

If a child feels bullied at Starling here are some things you can do:

- 1. Don't stay by yourself. Friends are important and you are less likely to be bullied when you are not alone.
- 2. Tell the teacher, the director, or your parents if you feel bullied.
- 3. Remember we will keep you safe.

A message to Bullies

If you feel the urge to bully, remember that your bullies grow up to be big bullies, and the consequences for older bullies get much more serious.

But bullies can change! If you need to stop bullying, talk to you teacher or director. We have some "cool off" strategies that may work.

Just remember that Starling has a "No Bully Policy" and zero tolerance for bullies. You will be expelled from Starling if you can't change your ways.

Before and After School Program Disciplinary and Behavior Management


A child's participation in Starling's before and after school program depends upon his or her behavior. We certainly want each child to enjoy the activities planned and benefit from their experience with the program.

Basic rules of safety and conduct are reviewed with the children. Please make certain that your child is aware of these rules. Parents will be informed by phone, in writing or through parent conferences if their child continues to display poor behavior. General discipline techniques involve positive reinforcement for good behavior and careful explanation of behavior that is unacceptable. An activity will be denied for repeated poor behavior and the child will be directed to an alternative activity. Physical restraint may be necessary if a child is threatening his own safety or those of others, or if the student is destroying property. Corporal punishment will not be used nor will food be denied as punishment.

Failure to comply with the following simple rules may lead to disciplinary action, possible suspension and/or termination from the program for:

- A. Repeatedly engaging in fighting as a way to solve an issue.
- B. Stealing or defacing the program or other children's property.
- C. Refusing to follow basic safety rules.
- D. Repeated disrespect for staff
- E. Repeated displaying an inability to follow established guidelines.
- F. Use of vulgar language.
- G. Discourteous behavior toward other children including disparaging remarks other race, religion, physical appearance etc. +

The parents will be given verbal and/or written notification of termination with a one week period for obtaining new services. Immediate termination could occur if the staff feels it cannot maintain the safety and welfare of the child and/or other children.






